Foster collaboration and partnerships, and engage local businesses and residents in efforts


Identify aspirational and practical actions with achievable early wins and ambitious long-term goals

ENERGY & WATER BENCHMARKING PROGRAM

A benchmarking and transparency policy is a market-based tool designed to overcome barriers and create demand for energy efficiency improvements in commercial, institutional and multifamily buildings. Energy benchmarking is the process of measuring a building's energy use over time. Benchmarking will give owners the information they need to identify opportunities to cut energy waste and understand how their building performs relative to similar buildings.

WE ALREADY ARE TAKING IMPORTANT FIRST STEPS

Reno adopted it Sustainability Plan in July, 2019. Prior to the release, the City of Reno partnered with Washoe County Health District, Reno-Tahoe Airport Authority, and University of Nevada, Reno to measure community-wide greenhouse gas emissions. The total carbon emissions dropped significantly from 3.2 million metric tons in 2008 to 2.75 million metric tons in 2014. This translates to a 13.62% drop in total emissions in just six years, or 2.27% per year.



CITY OF RENO PROGRAMS FOR BUSINESS

The City of Reno was one of twenty cities nationwide selected under the City Energy Project.
