5 Public Hearings

5.1 Staff Report (For Possible Action): Case No. LDC21-00026 (R & K Concrete Batch Plant) - A request has been made for a special use permit to: 1) allow for the establishment of a concrete batch plant operation; and 2) operate between the hours of 11:00 p.m. and 6:00 a.m. The ±5.4 acre site is located on the north side of Parr Boulevard ±1,000 feet west of its intersection with Ferrari McLeod Boulevard. The site is located within the Industrial (I) zoning district and has a Master Plan land use designation of Industrial (I). [Ward 4] 6:06 PM

Stacie Huggins and Eric Hasty with Wood Rodgers gave an overview of the R & K Concrete Batch Plant project.

Heather Manzo, Associate Planner, presented the staff report on the R & K Concrete Batch Plant project. Staff did not receive any calls or emails from the community on this project. Staff was able to make all the necessary findings for both the use and for the hours of operation.

Mr. Hasty answered Commissioner Gower's question regarding noise impacts and explained the requirements in Reno Municipal Code.

Alex Nichols, applicant, confirmed for Commissioner Johnson there is no signage anticipated on any of the silos or tall structures. There may be small signage at the gate entry.

Ms. Manzo explained for Commissioner Johnson that this type of equipment and structures are not subject to the maximum building height in those zones. It is equipment associated with the use rather than something that would fall under a building category.

Ms. Manzo confirmed for Commissioner Johnson the hours of operation are for this specific use. If the use changes, they would have to come in for a special use permit for whatever use is being proposed at that time. For this use, there was not a condition recommended to limit the night time operation.

Discussion

Commissioner Munoz stated his first concern was impacts to the houses in the area but after visiting the site he does not see this impacting anybody. With all the building going on for the freeway and in the North Valleys, this is a great project.

Commissioner Gower stated he believes his initial concerns regarding noise have been mitigated through the project design and various other factors described in the staff report.

It was moved by Commissioner Gower, seconded by Commissioner Olivas, in the case of LDC21-00026 (R & K Concrete Batch Plant), based upon compliance with the

applicable findings, to approve the special use permit subject to the conditions listed in the staff report. Motion carried unanimously with six (6) commissioners present.
