- I.1 Staff Report (For Possible Action): **Case No. LDC21-00016 (COPART)** Appeal of the Planning Commission's approval of a special use permit for the expansion of a nonconforming use of a wrecking yard, salvage yard, or junk yard (outside). The subject site contains three parcels totaling ±34.07 acres and is located ±450 feet west of the intersection of North Virginia Street and Stead Boulevard. The site has a base zoning of Industrial Commercial (IC). The Master Plan land use designation is Special Planning Area/Reno Stead Corridor Joint Plan (SPA/RSCJP). The original request was submitted prior to the RENOvation Code Update and adoption on January 13, 2021 and was reviewed under the previous Title 18 Land Development Code. **[Ward 4]**

The appeal of the Planning Commission's approval of the special use permit was brought by Snell & Wilmer L.L.P. as the representative of COPART. Possible action by City Council would be to approve, modify, or deny the request.
