Comments received prior to 4:00 p.m. on the day preceding the meeting will be transcribed, provided to City Council for review, and entered into the record. Comments received after 4:00 pm on the day preceding the meeting will be provided to City Council for review prior to adjournment, and entered into the record. Those wishing to address the Reno City Council in person shall submit a "Request to Speak" form to the City Clerk.

Public comment, whether on action items or general public comment, is limited to three (3) minutes per person. Unused time may not be reserved by the speaker, nor allocated to another speaker. No action may be taken on a matter raised under general public comment until the matter is included on an agenda as an item on which action may be taken. On specific agenda items, the presiding officer may prohibit comment if the content of the comments is a topic that is not relevant to, or within the authority of, the City Council, or if the content is willfully disruptive of the meeting by being irrelevant, repetitious, slanderous, offensive, inflammatory, irrational or amounting to personal attacks or interfering with the rights of other speakers. Any person making willfully disruptive remarks while addressing the Reno City Council & Redevelopment Agency Board or while attending the Reno City Council & Redevelopment Agency Board meeting may be removed from the room by the presiding officer, and the person may be barred from further audience before the Reno City Council & Redevelopment Agency Board during that session of the Reno City Council & Redevelopment Agency Board Attorney General Opinion No. 00-047 (April 27, 2001); Nevada Open Meeting Law Manual, § 8.05.

In addition, any person willfully disrupting the meeting may be removed from the room by the presiding officer. See, NRS 241.030(4)(a); RMC §§ 8.12.024, 8.12.027. Examples of disruptive conduct include, without limitation, yelling, stamping of feet, whistles, applause, heckling, name calling, use of profanity, personal attacks, physical intimidation, threatening use of physical force, assault, battery, or any other acts intended to impede the meeting or infringe on the rights of the Reno City Council & Redevelopment Agency Board, city staff, or meeting participants.

Items on the agenda may be taken out of order. The Reno City Council & Redevelopment Agency Board may combine two or more agenda items for consideration; remove an item from the agenda; or delay discussion relating to an item on the agenda at any time. See, NRS 241.020(3)(d)(6). Items scheduled to be heard at a specific time will be heard no earlier than the stated time, but may be heard later.

Council Recess: The Reno City Council may recess at any time during the meeting at the discretion of the Mayor and/or to confer with counsel per NRS 241.015(3)(b)(2) and/or its management representatives per NRS 288.220(4), as necessary. Additional short breaks may be taken throughout the meeting as needed.

D.3.1 Staff Report (For Possible Action): Request to amend Reno Municipal Code Title 5, entitled "Privileged Licenses, Permits and Franchises," amending Chapter 5.07, entitled "Alcoholic Beverages," to clarify the City's discretion to approve or deny package alcohol license applications with conditions; expand limitations for package alcohol and package wine and beer sales in the area currently defined under RMC Sec. 5.07.125 (to be known as "Downtown Safe Scape Area"); creation of newly defined areas to be known as "Downtown Safe Scape Buffer Area" and "East Fourth Street Corridor Safe Scape Buffer Area"; include new operational and safety standards including a fresh or frozen perishable food requirement with certain exceptions; prohibit or limit the sale of certain items within the Downtown Safe Scape Downtown Safe Scape Buffer Area, and East Fourth Street Corridor Safe Scape Buffer Area; together with matters which pertain to or are necessarily connected thereto. Request to amend Municipal Code Title 18 "Annexation and Land Development," Section 18.03.206 "Table of Allowed Uses," Section 18.03.304 "Commercial Uses," Section 18.03.405 "Standards for Specific Accessory Uses," Section 18.04.17 "Safe Scape Regulations," Section 18.09.303 "Commercial Uses," and Section 18.09.306 "Accessory Uses". These amendments would specifically establish package alcohol sales as a principal and accessory use, add regulations and definitions associated with the principal and accessory uses, relocate Safe Scape Regulations to Chapter 5.07, and reference relocated provisions in Chapter 5.07; together with matters which pertain to or are necessarily connected therewith.
