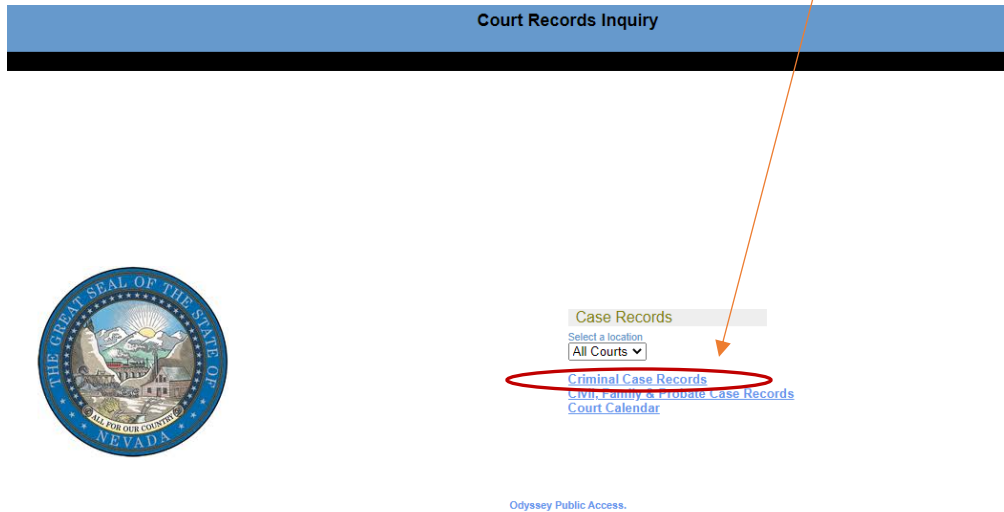
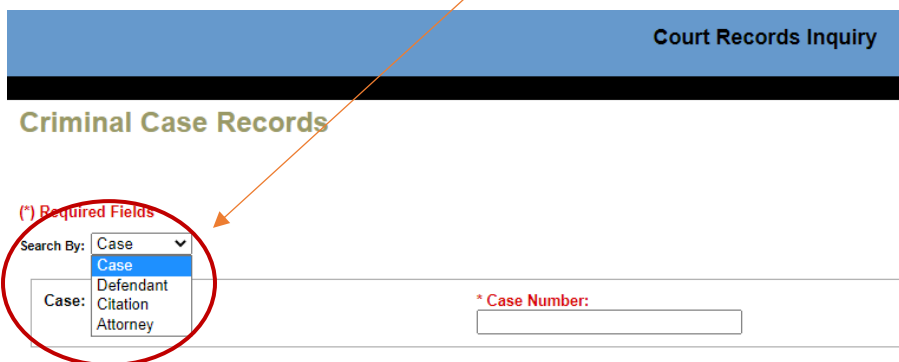


On the "Case Records Inquiry" page, click on "Criminal Case Records"



On the next page, you can use the drop down to search by Case Number, Defendant Name, Citation or Attorney.



- [Search by Case](#) - This is the case number issued by the court. i.e. 21TR-99999 or 22CR-99999. The case number must be entered in the exact format or no results will be located.
- [Search by Citation](#) - This is the case number issued by the law enforcement agency who completed the citation or arrest. Formatting can vary as we accept filings from eight different agencies.
- [Search by Defendant](#) - Enter the first and last name of the defendant. You can broaden your results by entering only the first three letters of the first and/or last name with an asterisk.

Example for John Smith:

- [Search by Attorney](#) — You can search by the attorney name or bar number:

Name Bar Number

If searching by name, you can broaden your results by entering only the first three letters of the first and/or last name with an asterisk.

Once you have entered all of the required information into the search fields, click search.

You will either receive a list of relatable cases OR a message that no results were found.
