Jason Garcia-LoBue, Planning Manager, presented a video presentation about Managing the Planning Commission Meeting.

6 Public Hearings

6.1 Staff Report (For Possible Action): Case No. LDC22-00067 (LDS Church Security Fence) – A request has been made for a major deviation to allow for a security fence exceeding four feet in height to be located in the required front yard area and within 20 feet of each side of a primary driveway. The subject ±2.56 acre site in located in the Multi- Family Residential – 30 units per acre (MF-30) zoning district on the northwest corner at the intersection of Neil Road and Filbert Road. The subject site has a Master Plan land use designation of Mixed-Neighborhood (MX). [Ward 3] 6:04 PM

Mark Denison, LDS Church Facilities Manager, gave an overview of the project.

Bishop Dennis Ford and Stake President Brent Farr were also present and spoke regarding the project.

Leah Brock, Assistant Planner, gave an overview of the project.

Questions:

Ms. Brock confirmed for Commissioner Johnson that a survey is not required for a standard fence permit. That requirement has been added as a condition of approval. The site plan that will be required will be more detailed regarding the fence location.

Discussion:

Commissioner Villanueva thanked staff for requiring that the gate be moved in so a car can wait while it is opening. She also expressed appreciation that the applicant is requesting an ornamental fence and not just a chain link fence, noting it will fit in better in the area and with the neighboring site with a similar fence.

Commissioner Johnson stated that this is one of the few sites in the area that does not have a fence around it, which is probably contributing to some of the issues. It is easy to make the compatibility finding.

It was moved by Commissioner Johnson, seconded by Commissioner Drakulich, in the case of LDC22-00067 (LDS Church Security Fence), based upon compliance with the applicable findings, to approve the major deviation, subject to the conditions listed in the staff report. The motion carried unanimously with five (5) commissioners present.
