Chief Examiner also introduced Brenda Nguyen, the newest Civil Service Management Analyst, and thanked the Civil Service Team for their hard work and efforts.

Chief Examiner announced that recruitments are slowing down in demand. There are 10 recruitments currently open and one more opening tomorrow. Civil Service expects demand to increase again in the coming months.

Chief Examiner Ackermann informed the Commission that the Civil Service Team has attended some training including a two-day Job Analysis training with ioPredict and an HR conference provided by Lattice. The Civil Service Team also attended the Pillars of Service Awards, the DEI Speaker Series, and the Fire Pinning Ceremony. Civil Service has also met with almost every department over the last month to work on test development, recruitment, and the selection process.

Chief Examiner also mentioned that Civil Service is actively working on Fire Captain Assessment Center, coming up next month. The Fire Department has a lot of vacancies but there were not a lot of applicants for this particular recruitment.

Chief Examiner Ackermann reported to the Commission that the Civil Service Team was part of all the Comp & Class Study meetings. The Civil Service Team will be available for group work sessions and office hours to assist employees in completing the forms. Civil Service is committed to helping facilitate the completion of the forms and ensure the success of the study..
