SUBJECT: Summary of Claim Payouts from the City of Reno in 2022

During the May 3, 2023 Reno City Council and Redevelopment Agency Board Special Meeting Agenda Item B.1 discussion, staff was asked to provide a summary of claims payouts from the City of Reno.

In Calendar Year 2022, \$1,363,038.57 in total payments were disbursed; \$974,840 (71.5%) of the \$1.36 million total was the settlement amount for a single claim. The remaining 28.5% (\$388,198.57) was paid over multiple claims.
