At the August 22, 2023, Board of County Commissioners (BOCC) meeting, agenda Item No. 8 will be heard, recommending the Board to consider a request from Southwestern Property Corporation (SWPC) for Washoe County staff to negotiate an easement across the Regional Public Safety Training Center property. The agenda item reads as follows:

TMP-7598 Recommendation to consider a request from SouthWestern Property Corporation (SWPC), as requested by Commissioner Clark, for Washoe County staff to negotiate an Easement Deed and Easement Agreement between Washoe County ("Grantor") and SWPC ("Grantee") for design, construction, installation, use and maintenance of a requested emergency access road, including relocation of an existing public utility easement and associated improvements over, across and through a portion of Washoe County property Assessor's parcel number (APN) 520-250-31, (5100 Spectrum Boulevard, Regional Public Safety Training Center) located at the terminus of Spectrum Boulevard Reno, Nevada. Said easement request would provide for emergency ingress/egress to the adjacent City of Reno approved residential development; and if approved, authorize County staff to negotiate an Easement Deed and Easement Agreement and require staff to present the negotiated Easement Deed and Easement Agreement to the County Commission for approval at a later date. A copy of the BOCC agenda is attached.

The easement, which SWPC is seeking, provides an emergency access road and relocation of a public utility easement associated with the Spectrum-Dandini mixed use project (Case No. LDC21-00040). The mixed-use project was approved by the Reno Planning Commission in 2021 and allowed for a development consisting of 420 multi-family residential units, child care facility, 120-room hotel and 4,800 square feet of restaurants and drive-through facilities. Primary access to the site is from Spectrum Blvd. In order for the project to move forward, they must provide a secondary emergency access to the site. The applicant is requesting that the emergency access road be located through the Regional Public Safety Training Center parcel, which requires approval by the Board of Washoe County Commissioners, as Washoe County owns the parcel.

The Reno Fire Department and the Reno Police Department, along with the ¹Washoe County Sheriff and the Sparks Police and Fire Departments oppose the project. A letter detailing our concerns was sent to the Board of Washoe County Commissioners. A copy of that letter is attached.

We are bringing this to your attention because the Spectrum-Dandini mixed-use project is within the City of Reno boundaries. While the easement sought under agenda item #8 will not require the City's approval, the mixed-use development project is within the City of Reno. The development was approved by the Planning Commission and no further public hearings are required. The project is now at the building permit stage and prior to moving forward, must provide a secondary emergency access route. We bring this to your attention so that you are aware of the project, and to highlight the concerns raised by region's Public Safety Departments. We are available should you have any questions or concerns.

Re: Opposition to granting of access easement and development of access road through property used by Regional Public Safety Training Center and Regional Emergency Operations Center to ensure continued and uninterrupted critical training of first responders and emergency response.

Dear Chairman Hartung, Vice Chairman Hill, Commissioner Clark, Commissioner Garcia, Commissioner Herman,

The Executive Committee for the Regional Public Safety Training Center (RPSTC) strongly opposes the Southwestern Properties' proposal for the development of an access road and easement through the training center. Our opposition is based on interference with the mission of the critical training of first responders, future expansion of the training facility, and safety concerns about the proposal.

The mission of the RPSTC is to ensure our community's first responders receive the critical training needed to respond to any emergency. The RPSTC provides fire, law enforcement, and emergency management personnel with training resources and supreme educational programs in a state-of-the-art local facility. This region's first responders receive vital training in a cost-effective manner through the RPSTC because of the significant and long-term commitment and cooperation of Washoe County and the cities of Sparks and Reno dating back to 2005. The RPSTC has five live firearm ranges, a seven-story firefighter training tower, a vehicle operations course, a four-wheel drive terrain course, a functional rubble pile and confined space training for tactical fire and search and rescue exercises.

Additionally, Washoe County, Reno, and Sparks joined together to create the Regional Emergency Operations Center (REOC) so that our regional community would have a single, secure, and safe location for the participating agencies to work together to make critical decisions during emergency and disaster situations. Our community's Homeland Security Program, which safeguards members of our community against both natural and human-caused threats, is housed within the REOC. The Emergency Management Program, which assists local agencies and communities in preparing for and responding to emergencies, is also housed within the REOC. Our region proudly includes Pyramid Lake Paiute Tribe, Reno Sparks Indian Colony, the City of Reno, the City of Sparks, the Washoe County School District, and the Washoe County Health District. Lastly, this area also houses our Regional Dispatch Center which provides the critical mission of intake of 911 calls and dispatch first responders throughout our region.

Southwestern Properties presented their plans before the Executive Board of the RPSTC. The Executive Board chaired by the Washoe County Sheriff has concerns that creation of an emergency access roadway through the site does not align with the use of the training center. The access road may encumber vital training operations for our first responders. Additionally, the access road will use land that has already been identified for continued and planned growth of our training facilities and would impede the expansion plans for Regional K-9 Operations as well as a Regional Mounted Horse Unit training facility. There are also concerns about how future development of the surrounding area could put further restrictions on our firing ranges and other training facilities.

In addition, the access road will create a weakened point within our exterior perimeter fencing, noting the continuous training and now exposure to additional liabilities that may occur by allowing a possible access point for the public to gain entry onto our facility.

Our community relies on its RPSTC and Regional Emergency Operations Center to protect the health, safety, and welfare of Washoe County and its residents. The public safety needs of our community continue to both grow and evolve. These Centers and surrounding areas need to be maintained and protected to provide them the ability meet the continuously changing public safety needs of our community.

Irrelevant statements, unduly repetitious statements, and personal attacks that would objectively antagonize or incite others are examples of speech that may be reasonably limited. All comments are to be directed to the Commission as a whole.

During the general public comment period at the end of the meeting, speakers may address any matter either on or off the agenda. Items voted on in the Consent section or in a separate block or blocks shall have a single public comment period per block, and public comment will only be heard about the specific items being considered by the Commission in the block. For the remainder of the agenda, during items designated "for possible action" that are considered individually, public comment will only be heard about the specific item being considered by the Commission.
