  - 4.1 Reno City Planning Commission Regular August 16, 2023 6:00 PM (For Possible Action)

Commissioner Armstrong stated he would abstain since he did not attend this meeting. With only three commissioners left in attendance today, this item was continued to the next Planning Commission meeting for approval.

- 5.1 **PULLED ITEM** Staff Report (For Possible Action Recommendation to City Council): Case No. **LDC24-00007** (**Note-able Music Therapy Services Specific Plan District**) A request has been made for a zoning map amendment from the Public Facilities (PF) zoning district to a Specific Plan District (SPD). The ±3.0 acre site is located on the south side of Orovada Street approximately ±285 feet east of its intersection with Silverada Boulevard (2590 Orovada Street). The subject site has a Master Plan land use designation of Public/Quasi-Public (PQP). [Ward 3]
- 5.2 PULLED ITEM Staff Report (For Possible Action): Case No. LDC24-00006 (Saia Truck Terminal) A request has been made for a conditional use permit to allow for the establishment of a truck terminal park in the Industrial Commercial (IC) zoning district. The ± 10.92 acre site is located on the south side of Mill Street approximately 750 feet east of the intersection of Mill Street and South Rock Boulevard. The site has a zoning designation of Industrial Commercial (IC) and a Master Plan land use designation of Mixed Employment (ME). [Ward 3]
- 5.3 Staff Report (For Possible Action): Case No. LDC23-00066 (Liberty Flats Townhomes) A request has been made for a tentative map for a 21-lot single-family attached (townhome) subdivision. The ±0.71 acre project site located on three parcels on the southwest corner at the intersection of Holcomb Avenue and East Liberty Street (330 East Liberty Street). The site is located in the Mixed-Use Downtown Riverwalk District (MD-RD) and has a Master Plan land use designation of Downtown Mixed-Use (DT-MU). [Ward 3]

The applicant requested a continuance on this item.

5.4 Staff Report (For Possible Action): Case No. LDC23-00053 (2400 Valley Road) – A request has been made for a conditional use permit to reestablish a previously existing, nonconforming warehouse and distribution use. The ±1.51 acre project site is located on Valley Road, ±214 feet south of its intersection with Enterprise Road (2400 Valley Road). The project site is located within the Multi-Family Residential – 30 units per acre (MF-30) zoning district and has a Master Plan land use designation of Suburban Mixed-Use (SMU). [Ward 4]

Dave Snelgrove, Applicant Representative, gave an overview of the project.

Carter Williams, Assistant Planner, presented the staff report. Staff was able to make all of the findings and recommends approval.
