Chief Examiner Ackermann informed the Commission that there has been a decline in the number of vacancies. Currently, there are 50 vacancies within the classified service of which 20 are Police Officer Recruits. The Reno Police Department is looking to fill the 20 spots for the upcoming 2024 Winter Police Academy and the Civil Service team is on track to meet the goal. Chief Examiner Ackermann thanked Sneha Sharma, Civil Service Technician, for all her hard work in spearheading the new testing process and coordinating with candidates.

Chief Examiner Ackermann informed the Commission that Civil Service currently has five recruitments open, six more opening this week.

The Civil Service Team held its first Lunch & Learn event on August 17, 2023. The event was a huge success with over 20 employees attending to learn more about Voluntary Transfers and Demotions. Chief Examiner Ackermann thanked Sneha Sharma, Civil Service Technician for her efforts in organizing the event and kick-starting this quarterly series. The team will bring the event to Corp Yard in October to present it to the employees of the Maintenance and Operations department.

Civil Service in partnership with Parks and Recreation department hosted the inaugural Career Day event on August 18, 2023. Rossmery Diaz, Civil Service Technician took the lead on this and worked with multiple departments to set up information booths and organize raffle prizes. AJ Kenneson and Brenda Nguyen, Civil Service Management Analysts put together workshops on completing job applications, testing processes, and eligibility lists. Cody Freeman and Jessica Noonan-Phipps from the Human Resource department presented on tips for effective interviews. The event was very successful, with attendees staying engaged till the end to participate in all the workshops. Based on the positive response, the team is considering hosting the event every 6 months.

The Civil Service Team is wrapping up its third-quarter meetings with departments. Chief Examiner Ackermann thanked AJ Kenneson and Brenda Nguyen, Management Analysts for doing a great job explaining how the test development process works thereby setting realistic expectations regarding the time required to conduct a recruitment. Civil Service will commence the fourth-quarter meetings beginning in October.

The Civil Service Team met with the Citywide Safety Assessment Contractor who is conducting citywide safety audits. The report will be shared with the commission once it has been submitted.

Chief Examiner Ackermann informed the Commission that Civil Service has had several meetings with the City audit team and the audit process is concluding soon. The findings of the audit will be shared with the commission once the results are received.

The Civil Service team kick-started the Fire Captain assessment and had the first meeting with the assessment team. Chief Examiner Ackermann thanked Bradley Jensen, Battalion Chief for his role in initiating discussions with subject matter experts (SMEs) and assisting

with the kickoff with the assessment team. The Fire Captain written test is scheduled for next month, and the assessment center in November 2023.

The City organized a Safety Challenge in the month of August and Civil Service tied for first place in two categories. The winner will be decided through a contest of rock-paper-scissors and Brenda Nguyen, Management Analyst will be representing the Civil Service team.
