SUBJECT: Update on the Projects listed in the Regional Transportation Commission

Interlocal Cooperative Agreements FY2020 through FY2024

Since the Council approval of the annual Interlocal Cooperative Agreement (ICA) for FY2020-2024, RTC staff and City staff have been working diligently to complete the projects. The purpose of this memo is to provide the status update on each of the projects listed and to provide Council the awareness that the next annual ICA (FY 2025) will be on March 13, 2024, City Council agenda for approval.

Per state laws, an ICA is needed to specify the responsibilities for delivering new projects located within the jurisdiction of the City and provide authorization for the RTC to exercise the power of eminent domain, if necessary.

Prior to the development of each local ICA, federal law requires that the RTC adopt a 20-year Regional Transportation Plan (RTP) and develop a 5-year plan Regional Transportation Improvement Plan (RTIP) that includes all the regional road projects and the funding source. The RTC requested input at the February 12, 2020, City Council meeting and then provided an update to the Council at the January 27, 2021 City Council meeting on the 20-year plan (2050 RTP). The 2050 RTP plan was adopted by the RTC Board on March 19, 2021. All the projects are also listed in the Council approved ICA's are also included in the RTC's RTIP.

The ICA agreements are necessary to proceed with the work contained in these programs. Separate agreements are prepared by the RTC for each jurisdiction based on where the projects reside. This provides clarity to the overall program of projects and simplifies the process so that the approval of each ICA can occur independently; therefore, delays that may occur with one jurisdiction will not affect the ICA approval of another.
