		asphalt on the shoulder of a road in which traffic rarely yields to pedestrians demanded me to take action.					
		I recently submitted a concern to The City of Reno for obstructed sidewalks within my apartment community					
		(case number SER0049585). According to the comments on the case, it was closed because "The City of					
		Reno has no authority to enforce". This excuse, however, is not true. Every level of governance from the US					
		Department of Justice all the way down to local home owner's associations (HOAs) has the authority to					
		enforce the regulations set forth by the Americans with Disabilities Act (ADA). Code enforcement offices,					
		such as the City of Reno's Parking and Code Enforcement Department, exist specifically for this purpose					
		(among others). All I am asking is that they perform the duty that is literally in their name: enforce code.					
		My goal is the safety of our disabled family, friends, and neighbors in my community: a goal that I hope we all					
		share. Unfortunately, I have received the exact same excuse from The City of Reno that I have received from					
		our property manager, our HOA, and even Lacey Stange of the Department of Justice: Housing and Urban					
		Development Division: "we have no authority to enforce". In every case, that excuse is a lie. The regrettable					
		truth is that any single one of these governing bodies, alone, is capable of fixing the problem, but none					
		choose to.					
		Please be the one to make a difference. Please be the one body of government that cares enough to protect					
		the rights of our Renoites with disabilities. They deserve the right of sidewalks free of obstruction granted to
