Unfortunately, neither the US Justice Department, the City of Reno Office of Code Enforcement, my property manager, or my HOA is willing to fix this problem even though every single one has the authority to do so. The sad reality is that it would only take one of these agencies to care enough about our disabled neighbors to fix the problem, but none of them do.</p> <p>Please do not respond to this case with the equivalent of "No ADA violations were found on site". This, too, is an objective falsehood. I have provided more than 30 photos proving that statement untrue, and Antonio Gilmore, Code Enforcement Officer, documented several violations during his brief site visit on 04/26/2024. All of our sidewalks are in a constant state of ADA violation, especially before 0800 and after 1800. A survey of our complex at those times would find no less than 20 violations.</p> <p>Please do not respond to this case by telling me to reach out to the US Department of Justice. They, like the City of Reno, have incorrectly told me that they have no authority to enforce the ADA.
