They did not resolve this situation until well after 6:30 p.m.</p> <p>The backyard of this business IS NOT SECURE. I have submitted complaints regarding this concern before. They have the fence gate that connects the backyard to the front yard blocked with a broken ping pong table. There are NO LOCKS on this gate. It's pretty easy for the patients to get around the broken ping pong table out of the backyard, and on their way to elopement; or they linger in the space that my front yard, backyard and living space shares with this business and its property line.</p> <p>Last week it was made known that a sexual assault, rape, on a 14 year old female patient took place at this business in late March when I received police reports connected to this property. Patients continue to be unsupervised. How can this business be allowed to be co-ed; especially since these are teens going through puberty? How is ANY OF THIS ACCEPTABLE? Who do I have to talk to get my message across? The evidence is clear. Do we have to wait for a UNR Student, or someone of means to get shot in order to stop this violence??? I am available to talk to whatever authorities I need to, in order to keep someone else from getting hurt, or killed.
